# THE GURSTON DOWN 2017 HILLCLIMB CHAMPIONSHIP AND THE BARC (SW) GURSTON DOWN 2017 TOP TEN CHALLENGE

## Organised and administered by the BARC (SW) Regulations and details of Annual Trophies

- 1 The Gurston Down 2017 HillClimb Championship and 2017 Top Ten Challenge are organised and administered by the BARC (South Western Centre) in accordance with the General Regulations of the Royal Automobile Club Motor Sports Association Ltd (incorporating the provisions of the international sporting code of the FIA) and these Championship Regulations. MSA permit numbers CH2017/TBA (Grade C) (Championship) and CH2017/TBA (Grade C) (Challenge) have been issued.
- 2 Drivers and Entrant/Drivers must be fully paid up valid membership card-holding members of the BARC (SW) throughout the season, be Registered for the Championship and be in possession of valid Grade National B Competition Licence, as a minimum. All necessary documentation must be presented for checking at all rounds when signing-on.
- Those wishing to register for the Championship and/or Challenge must do so on the enclosed Entry Form. The fee will be £20 for either or both. Registration will NOT guarantee an entry at any meeting. The registration list will close on May 14th 2017. No points will be awarded retrospectively. Contenders will be required to carry sponsorship decals on their competition cars.
- 4 The dates for the qualifying rounds of these championships are as follows: April 22nd, June 17th, June 18th, July 22nd/23rd and September 10th. Please note: All other events are not rounds of either the Championship or the Challenge.
- Each qualifying event will be organised by the BARC (SW) and will run under its own SRs. Championship entrants will be bound by those SRs and the GRs of the MSA and these Championship Regulations. All vehicles must comply with the Technical and Safety Regulations defined in S10.1.1 to S15 as applicable.

  Competitors in individual qualifying events will take part in their appropriate Class for awards offered at that meeting.
- 6 For the purposes of Championship marking vehicles will be divided into the following Classes:

Roadgoing Series Production MX5's Mk1-Mk2.5 up to 2000 cc. (Normally Aspirated)
Roadgoing Series Production Cars up to 2000 cc (excluding vehicles with non-ferrous chassis).
Roadgoing Series Production Cars over 2000 cc (excluding vehicles with non-ferrous chassis).
Roadgoing Specialist Production Cars, any capacity.
Modified Limited Production Marque Sports Cars up to 2000 cc.
Modified Limited Production Marque Sports Cars over 2000 cc.
Modified Series Production Cars up to 1400 cc.
Modified Series Production Cars over 1400 cc and up to 2000 cc.
Modified Series Production Cars over 2000 cc.
Modified Specialist Production Cars, any capacity.
Historically Interesting Cars complying with S10.10.6, any capacity, built up to and including 1972. Tyres
are free. Wings are permitted where originally fitted.
Hillclimb Supersports Cars.
Sports Libre Cars up to 2000 cc.
Sports Libre Cars over 2000 cc.
Racing Cars up to 500 cc complying with the eligibility rules of the '500 Owners Association'.
Racing Cars up to 600 cc.
Racing Cars over 600 cc and up to 1100 cc.
Formula Ford Racing Cars manufactured pre-1994, Kent Crossflow engines only. Pre-1994 rules apply.
Racing Cars built up to 1985 (car-derived engines only).
Racing Cars over 1100 cc and up to 1600 cc.
Racing Cars over 1600 cc and up to 2000 cc. (Normally Aspirated)
Racing Cars over 1600 cc and up to 2000 cc. (Forced Induction)
Racing Cars over 2000 cc.

- i) Classes 4a and 4b for the purposes of the Gurston Championship will comply with MSA Yearbook 2017 Section 'S', and will include the Standard Working Specification of the vehicle when it left the factory, as based on the vehicle registration number supplied.
- ii) Class 4c for the purposes of the Gurston Championship will comply with MSA Yearbook 2017 Section 'S', and will include both a seat and seatbelt/harness for the passenger side of the vehicle.
- 7 In order to qualify for points in any event, a competitor must be classified as a 'finisher'. In the case of *force majeure*, should only one complete run be attained, points will be scored on that one run.

## 8 THE CHAMPIONSHIP

- i) Points will be awarded as follows: 1st place in class will score 20 points plus the time difference between 1st and 2nd place, up to a maximum of 21.50 points; 2nd place in class will always score 20 points; all other registered finishers' scores will be based on their time relative to that set by 2nd place e.g. a time 1.35 seconds slower than 2nd place will score 20.00 1.35 = 18.65 points, et cetera.
- ii) If there is only one finisher in class, if registered he/she will score 20 points plus a bonus if they achieve the following, based on the existing class record at the start of the meeting; within 0.00 to 0.25 secs of the record, plus 1.50 points; within 0.26 and 0.50 secs, plus 1.00 points; within 0.51 and 0.75 secs, plus 0.50 points.
- iii) If there are only 2 finishers in a class, if registered the winner will score 21 points. He/she will also score 0.50 extra points if they are within 0.50 sec of the existing class record. Likewise he/she will score 0.25 extra points if they are between 0.51 and 1.00 secs of the respective class record.
- iv) An additional bonus point will be awarded to any competitor breaking an existing class record on the day, based on records at the start of the meeting.
- v) All competitors, registered or not, will count towards the scoring system, with points only being awarded to registered contenders.
- vi) Points gained in FOUR of the qualifying events will count towards the Championship scoring total.
- vii) Competitors may score points in more than one class, but these will not be added together to count towards the overall championship total.
- viii) In the event of a tie between two or more competitors the following tie-break procedure will be adopted in the sequence shown below until a result is achieved:
  - a) If appropriate to all tieing competitors, the fifth score will be considered.
  - b) The competitor who has been closest to the class record, as at the beginning of the season shall be the winner.
  - c) The competitor who has broken the existing class record the greater number of times shall be the winner.
  - d) The competitor who has recorded the fastest time in a competition run at a Championship/Challenge round shall be deemed the winner.
  - e) Should none of these methods be effective, the Committee of the BARC (SW) will decide what further action should be taken.
- ix) At the conclusion of the Championship, trophies will be presented as follows:

1st overall The Wadham Stringer Trophy (to be returned by 1.10.17), £250 cash and a souvenir trophy.

2nd overall A souvenir trophy
3rd overall A souvenir trophy

1st in each Class
2nd in each Class
A souvenir trophy (providing there are 3 or more registered participants)
A souvenir trophy (providing there are 5 or more registered participants)
A souvenir trophy (providing there are 9 or more registered participants)

1st in Class 13

The Keir & Cawder Quaich and a souvenir trophy
1st in Class 19

The Tom Elton Trophy and a souvenir trophy
1st in Class 20

The A & S Racing Trophy and a souvenir trophy
1st in Class 20b

The Warren Trophy and a souvenir trophy
1st in Class 21

The Chairman's Cup and a souvenir trophy

The Committee of the BARC (SW) may offer additional trophies.

## 9 THE TOP TEN CHALLENGE

- i) Championship Regulations 1 to 7 above apply.
- ii) The ten competitors with the best times overall from the Class runs, irrespective of class, will be awarded points. There will be 10 points for the best time down to 1 point for the tenth best time.
- iii) Points scored in FOUR qualifying events will count towards the Challenge scoring total.
- iv) In the event of a tie between two or more competitors the tie-break procedure will be the same as 8(viii) above.
- v) At the conclusion of the Challenge trophies will be presented as follows:

1st The Guards Trophy (to be returned by 1.10.17), £250 cash and a souvenir trophy

2nd A souvenir trophy 3rd A souvenir trophy

- 10 If a competitor wins both the Championship and the Challenge at the end of the season, he/she shall receive the Championship trophy only. Gaps left in the listing will be filled by the promotion of those competitors in lower positions.

- ii) Championship in accordance with Section C of the 2017 MSA Year book and the BARC SRs.
- 13 All other relevant GRs of the Motor Sports Association Ltd apply as written.
- 14 Only Registered Contenders in the Championship or Challenge are eligible to win Annual trophies.

## **ANNUAL TROPHIES 2017**

## MARSH MEMORIAL TROPHY

This Trophy is awarded to the BARC Championship Competitor who makes the greatest improvement or nearest to their class record in the two June meetings.

## **EQUIPE BRUTONI SHIELD**

This Shield is awarded to the BARC Championship Competitor driving a 500 cc Racing Car (in Class 17) who achieves the fastest time at Gurston Down in this season.

#### RECORD DESIGNS MX5 AWARD

This Award is awarded to the driver of the highest placed Mazda MX5 car (Class 4a-MX5) in the Gurston Championship.

## **CORONA CHALLENGE CUP**

This Cup is awarded to the South West Centre member who makes the greatest improvement on a Class Record as at January 1<sup>st</sup> during the ensuing season.

## **HEATHER BRAMPTON TROPHY**

This Trophy is awarded to the lady Competitor who finishes highest in the Gurston Championship.

## **LOGETTE CUP**

This Cup is awarded to the driver of the highest placed Saloon or Closed Sports car in the Gurston Championship.

## **TERENCE TATTAM MEMORIAL TROPHY**

This Trophy is awarded to the driver of the highest placed Open Sports car in the Gurston Championship.

#### **KEIR & CAWDER QUAICH**

This Trophy is awarded to the driver of the highest placed Historically Interesting Car in the Gurston Championship.

## **WARREN TROPHY**

This Trophy is awarded to the driver of the highest placed Racing Car built up to 1985 (Class 20b) in the Gurston Championship.

## PITT TROPHY

This Trophy is awarded to the driver of the highest placed Sports Libre Car in the Gurston Championship

## **TOM ELTON TROPHY**

This Trophy is awarded to the driver of the highest placed 1100 cc Racing Car in the Gurston Championship.

## **A & S RACING TROPHY**

This Trophy is awarded to the driver of the highest placed 1600 cc Racing Car in the Gurston Championship.

## THE CHAIRMAN'S CUP

This Cup is awarded to the driver of the highest placed 2000 cc Racing Car in the Gurston Championship.

## **DPC TROPHY**

This Trophy is awarded to the competitor scoring the highest number of points in the Championship who has not won an award at any Gurston meeting during the year.

## **PITSTOP TROPHY**

This Trophy is awarded to the 'Driver of the Season' who has not won an Annual Award, as decided by the committee.

## **KEITH SALMON MEMORIAL TROPHY**

This Trophy is presented to the South Western Centre member competing at Gurston based on Concours presentation and Championship performance.

## PARKHOUSE & WYATT CHALLENGE TROPHY

This Trophy is presented to the winner of a Competition Car Concours, who must be a South West Centre member, judged throughout the Gurston season. Cars will be judged on the basis of age, cleanliness, finish, safety and fitness for purpose.

## **MARSH & MASTERS TROPHY**

This trophy is awarded to the competitor scoring the highest number of points in the Gurston Championship who at the beginning of the season was 65 or over (60 or over for women).
